Burial Charges

Tables of fees, payments and sums as from 1st May 2018 (reviewed 17th February 2021)

The fees, payments and sums set out below apply where the person to be interred, or in respect of whom the right is granted, (or immediately before his or her death) was an inhabitant or parishioner of the area for which the Berkeley Burial Committee acts on behalf of the Burial Authority, or in the case of a still born child, where the parents (or one of them) are, or at the time of interment, were such inhabitants or parishioners.

The fees indicated for the various heads of parts 1, 2 and 3

- a. Apply only where the interment is made between the hours of 10 a.m. and 3.30 p.m. on a weekday, except in the months of November, December, January, February and March, when they are limited to between 10.30 a.m. and 3.00 p.m., or on the certificate of a coroner or registered medical practitioner that immediate interment is necessary.
- b. In the case of an interment made outside the hours given in (a) above an additional £100.00 is payable.
- c. There may be on certain occasions where adjacent graves may have to be reopened, it may be necessary to spread soil onto adjoining graves temporarily. This is another reason why graves must not be made into flower beds.
- d. NO FUNERALS WILL BE ALLOWED ON A SATURDAY OR SUNDAY.
- e. Under no circumstances will pet's ashes be buried outside of full graves or ashes graves.
- f. Pet's ashes may be buried within the casket or coffin at the time of funeral.
- g. Once a parishioner has left a contributing parish for more than 2 years, full fees will be applied. Unless agreed otherwise at the Berkeley Burial Committee's discretion.
